

Programme of two years duration with an another intake of 50 (Existing 50 intake + another 50 intake), thus making total intake 100 (Two basic units) from the academic session 2019-2020 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-"



ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Maharshi Paramhansh Seva Trust, Street/Road - 15 Gola Road, Vill/PO- Ramgarh Cantt, Tehsil/Taluka - Ramgarh, Town/City - Ramgarh, Dist - Hazaribagh, Jharkhand - 829122 has applied for grant of permission to Maharshi Paramhansh College of Education, Plot no - 2109, Vill - Huhua, Po - Ramgarh Cantt, Tehsil/Taluka - Ramgarh, Town/City - Ramgarh, Dist - Hazaribagh, Jharkhand - 829122 (Code No.- ERCAPP4132) for D.El.Ed. programme online on 30.06.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 09.07.2015.

2. **AND WHEREAS**, as per the decision of 213th ERC Meeting held on 29th - 30th April, 2016 & 1st - 2nd May, 2016, formal permission order under clause 7(16) for conducting D.El.Ed. course was issued vide No. 46106 dt. 02.05.2016 with an intake 50 (one basic unit) from the academic session 2016-17 to the institution.

3. **AND WHEREAS**, the institution filed W.P.(C) No. 2526 of 2016 in the Hon'ble High Court of Delhi. The Hon'ble High Court disposed of the matter on 21.03.2018 with a direction inter alia:

"Thus it is prayed by the learned counsel for the petitioner that the writ petition may be disposed of granting liberty to the petitioner to agitate the matter before the respondent no. 2, which may be considered by the respondent in accordance with law. Considering the aforesaid limited prayer made by the learned counsel for the petitioner, the present writ petition is disposed of with liberty to the petitioner to file an application before the respondent no. 2- Regional Director, National Council for Teacher Education (NCTE), Eastern Regional Committee, Bhubaneswar, agitating its grievance. The respondent no. 2 on receipt of such application shall consider the same and take appropriate decision in accordance with law".

4. **AND WHEREAS**, the ERC in its 256th meeting considered the order dated 21.03.2018 of the Hon'ble High Court of Delhi and reasoned order dated 11.06.2018 was issued informing the institution that the previous order for one basic unit 50 intake of D.El.Ed. from the academic session 2016-2017 issued vide order dated 02.05.2016 remain unchanged.

5. **AND WHEREAS**, the NCTE HQrs. vide letter dated 29.05.2018 requested to consider the petitioner case in the RC meeting as per the provisions available under NCTE Act and Regulation. In response to reasoned order dated 11.06.2018, reply dated 12.06.2018 submitted by the institution was considered by ERC in its 257th meeting and Show Cause Notice was issued on 12.07.2018. Now, reply dated 18.08.2018 received from the institution was considered by ERC in its 260th meeting held on 31st August & 1st September, 2018.

In view of the above, the Committee decided as under:

In addition to 50 intake already granted for D.El.Ed. Course from the academic session 2016-17 earlier, the Committee decided that formal permission order under clause 7(16) of the NCTE Regulation, 2014 for applied **D.El.Ed. Programme with another 50 intake** from the session **2019-2020** be issued to the institution, thus making the sum total grant of **100 intake**.

6. **NOW THEREFORE**, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants permission to **Maharshi Paramhansh College of Education, Plot no - 2109, Vill - Huhua, Po - Ramgarh Cantt, Tehsil/Taluka - Ramgarh, Town/City - Ramgarh, Dist - Hazaribagh, Jharkhand - 829122** for conducting D.El.Ed. programme of two years duration with another intake of **50 (existing 50 intake + another 50 intake), thus making total intake 100 (two basic units)** from the academic session **2019-2020** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c) Name of faculty members who left or joined during the last quarter;



- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application;
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.


10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available list of students admitted on its official website.

12. The Educational institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

13. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
